### **Description of necessary first aid measures**

### Section 4. First aid measures

#### **Protection of first-aiders**

No action shall be taken involving any personal risk or without suitable training. ## Section 6. Accidental release measures

#### Large spill

Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). # Appropriate engineering controls

Methyl n-Propyl Ketone

: Use only with adequate ventilation. #### **Hand protection**

Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary.
